**NOTES TO READ WHEN COMPLETING THIS APPLICATION FORM:**

1. If the aircraft is to be registered in the name of an unincorporated body or more than one individual the full names and addresses of all persons sharing the ownership should be given. In the case of an unincorporated flying group, whose assets are held by trustees, the names and addresses of the trustees holding the assets should be given together with a separate list of the full names, addresses, nationalities and percentage shareholding of all members of the group.
2. The owner of charterer (or agent with power of attorney) should sign personally; where more than one person is shown as owner each should sign. In the cases of a Body Corporate or Undertaking, a Director, Secretary or other authorised officer of the company should sign, stating the position they hold, and a covering letter should be attached to the application giving the names of all such authorised officers.
3. If the aircraft has been registered in another state, a Certificate should be furnished from the competent authorities in the state of such registration that the registration is cancelled.
4. Aircraft may be allocated any three letter sequence which is either not used, or has not previously been used, except for certain reserved groups of letters. Owners should note that the registration marks cannot be transferred from one aircraft to another.
5. The making of false statement for the purpose of procuring the issue of a certificate of registration is an offence under the Act 60 of 1960. The Directorate General of Civil Aviation may, in any case in which they think it is desirable, require the applicant for a certificate of registration to furnish such evidence as they may desire and to make and subscribe a statutory declaration as to the truth of the facts set out in the application.
6. This form, when completed, should be forwarded to the **Directorate General of Civil Aviation, Aviation Safety Department, P.O. Box 17, Safat 13001, State of Kuwait**, and must be accompanied by the appropriate registration fee according to the Kuwait Civil Aviation Safety Regulations Part 27. The fee may be paid by cheques/draft and made payable to the Directorate General of Civil Aviation with Central Bank of Kuwait. For application details please contact the Aviation Safety Department. 7. **All referenced manuals shall be submitted to the DGCA/ASD for review and approval at least 30 days prior to aircraft delivery.**
